



Dear Exhibitor,

Please find enclosed your entry confirmation, judging schedule and other pertinent information for DTCT's Obedience & Rally Trials June 27, 2009 – June 28, 2009.

Please note the following:

- All exhibitors need to review all information for their entry (s) and report immediately to the Trial Secretary any corrections to be made. Contact info: weims3@gte.net or at 813-737-2473 or 813-833-1346.
- **All move-ups for Saturday, June 27 MUST be submitted to the Trial Secretary no later than Monday June 22 by 6:00 pm.** No move ups for Saturday will be allowed after this date.
- **All move-ups for Sunday, June 28 MUST be submitted to the Trial Secretary BEFORE the close of the Trial on Saturday the 27th. No move-ups for Sunday will be allowed after this time.**
- Please clean up after your dogs. There is an exercise area in the front of the building. Anyone found not picking up after their dog(s) will be dealt with by the Trial Committee.
- Judges are not required to wait for any dog. We have a total of **186** entries for the weekend and ask that everyone be ready ringside when your # is up. Should you have a conflict you are responsible for getting with the Gate Stewards/or Judge to let them know of your conflict.
- All dogs must be either on leash or contained in a crate when not in the show ring.
- Please bring crates that are stackable as crating space is limited. There are crates available by students at the club who are not using those crates. Please be respectful of their crates and leave them in the same condition as you found them. No x-pens are allowed inside the building. As crating space is limited, exhibitors are asked to abide by the rules for the spaces allowed.
- Overnight camping is not allowed in the parking lot.
- There will be NO set up allowed on Friday night before the trial. The doors will open at 7:30 am both Saturday and Sunday mornings.
- **IMPORTANT** Parking information: The Barber Shop is longer in the building. **We have the entire lot for our parking**
- **There is absolutely NO practicing in the rings at ANY time nor is food allowed in the rings at any time.**
- **Lunch will be on your own. There are several eating establishments close by.**

Directions to the show site: From the North: Take I75 South and get on I275 where it splits just south of the Exit at Hwy 56. Continue on I275 to the Hillsborough Avenue Exit. Make a right (West) onto Hillsborough Avenue (US 92). Follow Hillsborough to Lois (about a 1/4 of a mile west of the Dale Mabry overpass). Make a left at the light onto N. Lois. The club is two blocks south on the left at 4817 N. Lois.

From the West/South: Take 275 North to Dale Mabry East (North Bound). Going North on Dale Mabry make a left (West) onto Dr. Martin Luther King Jr. Blvd which is just after the stadium. Make a right onto Lois. The club will be on the right in a couple blocks or so.

From the East: Take I 4 to I 275 to Dale Mabry East (Northbound). Going North on Dale Mabry make a left (West) onto Dr. Martin Luther King Jr. Blvd which is just after the stadium. Make a right onto Lois. The club will be on the right in a couple blocks or so.

- Bitches that come in season after the closing of entries will be allowed a refund, minus \$10 for the weekend, provided the Trial Secretary has written notice prior to the trial. Refund checks will be issued after the trial has closed on Sunday and will be mailed to the Exhibitor.
